The class dealt with the commissions, case laws and Anti ragging code of University Grant Commission. The Kerala Prohibition of Ragging Act 1998 make ragging punishable under Sec 4 which leads to imprisonment for 2years and fine for 10,000Rs in conviction. The faculty conducted an interactive session with students. The lecture series have empowered the students with courage to stand against ragging both mentally and physically. The Anti Ragging series has encouraged everyone to report any ragging inside the college campus also informing them all the consequences they have to face and ways they can file the complaint for the aggrieved person. It was attended by the students of 2nd, 7th and 9th semesters.
