16th November 2023

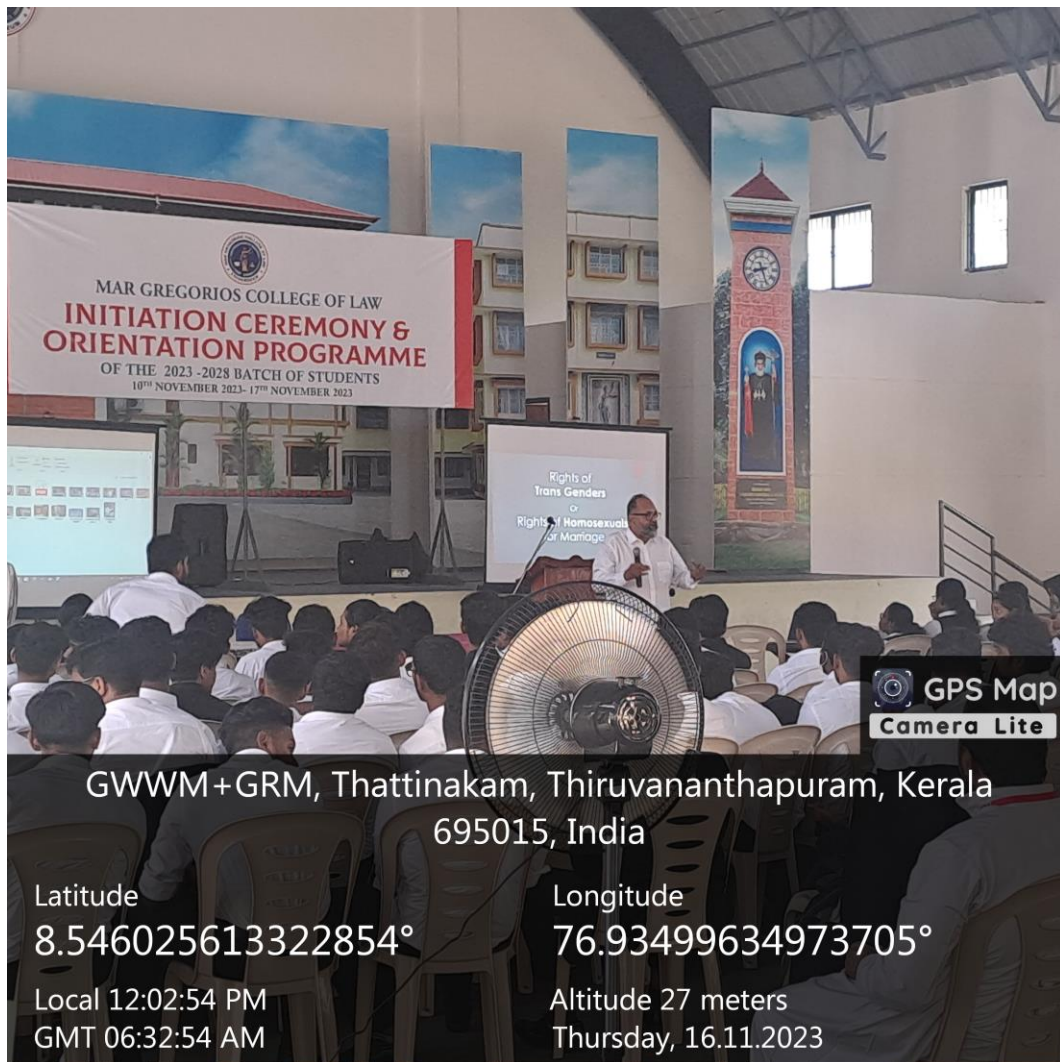
