LEGATHON 2022 -REPORT-

Legathon 2022 was held on 30th September 2022. The event involved four competitions of debate competition, paper presentation competition, article writing competition and crime scene investigation competition. The events were scheduled from 9:30 am to 1:30 pm, three events from 9:30 am and one from 11:30 am.

1. Debate competition

Debate competition was conducted from 11:30 am to 1:00 pm. The question of debate was 'Can state impose limits on the fundamental rights of students inside the classrooms?'. The event was moderated by Dheeraj S S (9th semester BBA LL.B) and Asbin F Mohammed (9th semester BCom LL.B). The judges of the competitions were Ms. Rehana Sherin K V and Ms. Ancy Varghese. The fact-checking team included Muhammed Nihal (7th semester Ba LL.B) and Jerom A J (7th semester BBA LL.B). 9 students from various classes competed for the positions of 'the best speaker' and 'the best debater'.
