## 8. **BUTTERFLY GARDEN**

The Centre for Environmental Studies through eco-club maintains a well – developed flower garden. The garden is an adobe of different local species of butterflies. Butterfly garden is not only beautiful but also is helpful to the environment in a number of ways.

Butterflies and other pollinators including bees maintain a relationship between the plants they visit and their preferences for organic and native habitats.

Butterflies and bees are some of the most important pollinators which help in reproduction in plants and the further development of plant species. These pollinators are susceptible to pesticides and insecticides. In the college, there is a butterfly garden with native plants which attract these showy insects like butterflies, bees etc.













## **9. ORGANIC FARMING**

Mar Gregorios College of Law promotes on and off campus organic farming. The members of Eco Club under the Centre for Environmental Studies actively engage in organic farming. The college encouraged the students to continue these activities of organic farming even during the

lockdown days. After the lockdown, the students again started the organic farming activities in the college. The students actively engage in taking care of the lands by picking the pests and adding suitable bio fertilizers. The students use natural biofertilizers such as cow dung, egg shell, vermicompost, coco peat for organic farming. Eco-friendly neem oil is used as pesticides.

### **Benefits of having an organic farming in College**

- Primarily, organic farming increases awareness among the students regarding the importance and benefits of organically grown vegetables.
- Generates farming interest in students and motivates them to have an organic garden at their homes.
- Organic farming creates an opportunity for students in knowing more about soil, farming, vegetables, farming tools and also engages them in more outdoor activities.
- Organic vegetables can be used in the college canteen.

In our college the eco club members have grown tomato, brinjal, chilli, Green and Red Amaranthus, lady's finger etc. After the lockdown, the college has restarted the organic farming.

















## **10.MEDICINAL GARDEN**

Our college has a well-maintained medicinal garden containing many varieties of medicinal plants. Each of these plants are considered an essential source in treating and preventing of various diseases. These plants contain many ingredients that can be used in medical field.

Our grandparents often use these plants for curing or preventing various diseases. In order to make the students and teachers aware of the medicinal use of these plants, the medicinal garden to an extent is successful. The medicinal garden in the college also helps in create a clean, green, and safe environment. Water is very essential for the survival of all living beings. Conservation of water is very important. It means water should be used wisely and keep water resources from pollution.

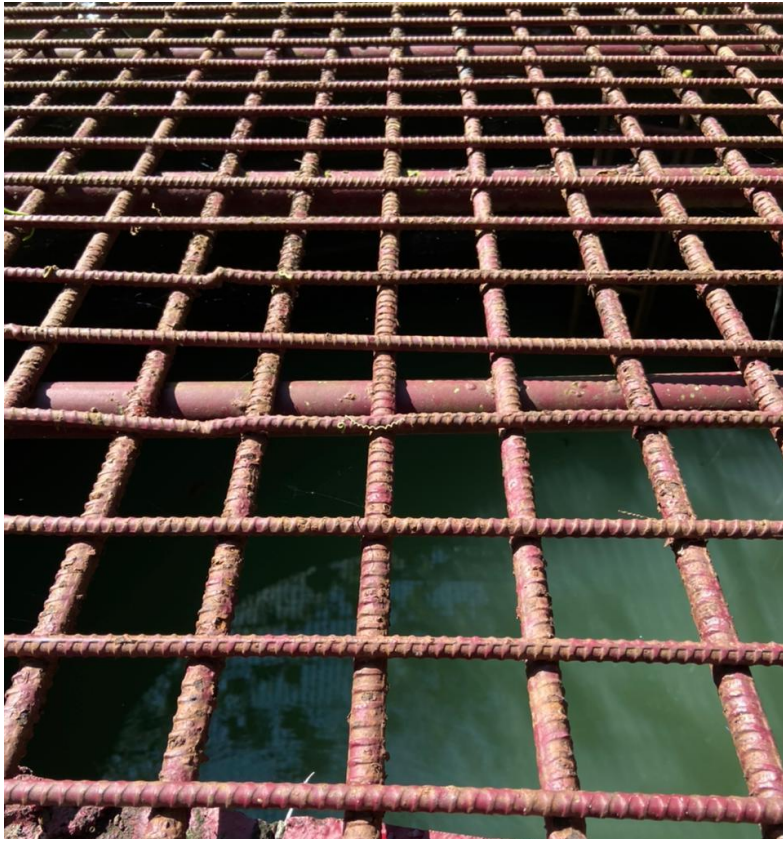
Rain water harvesting is one of the techniques through which water can be conserved. It is a sustainable water management practice whereby harvested water can be used for irrigation and many other purposes.

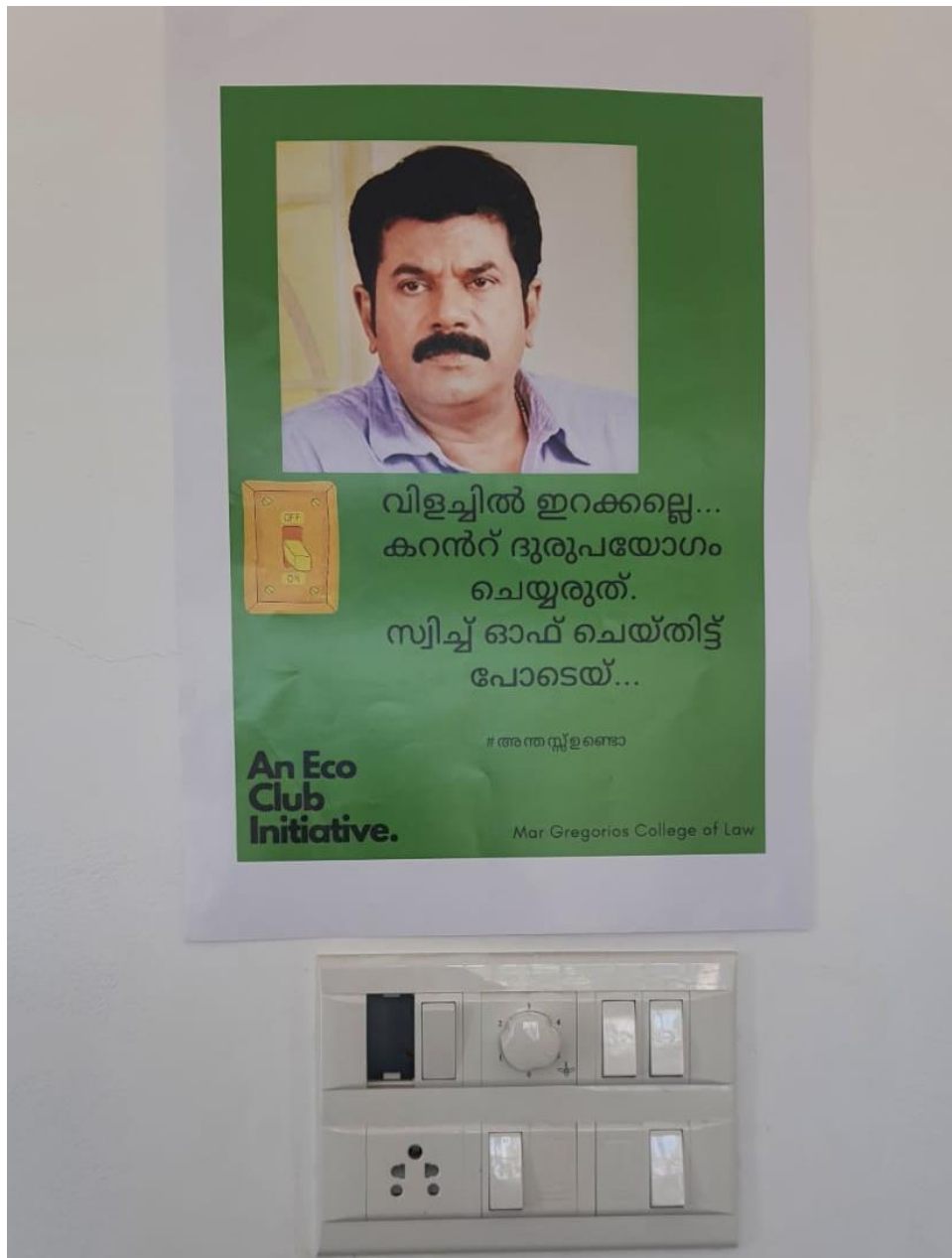

## **16. ELECTRICITY USE AND MANAGEMENT**

Mar Gregorios College of Law promotes reduced use of electricity by ensuring that the students, faculties, and other persons switch off the appliances after use. ## **17. WASTE MANGEMENT**

- **Solid Waste Management**

The solid waste generated within the campus is collected, segregated, and disposed properly following the guidelines issued by the government.

For the purpose of management of solid waste, the college has installed bio gas plant and incinerators.





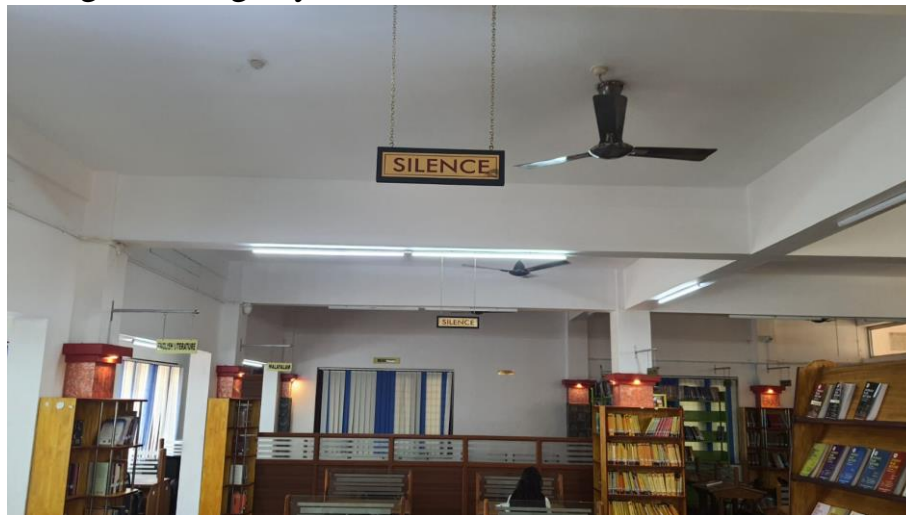
- **Liquid Waste Management**

The waste water is properly disposed ensuring that the water does not pollute the soil and the campus surroundings. Apart from that to an extent possible, the water is reused for farming and other purposes. The college has a well maintained system for liquid waste management.



## **18. ENVIRONMENTAL POLLUTION CONTROL**

- **Noise pollution management**  
Various display boards are kept within the library and other places in order to create awareness and to maintain silence in the college. The staff members and students are asked to refrain from pressure horns within the campus which is ensured by the security guard. For avoiding noise pollution and to create a peaceful ambiance in the campus, vehicles are not allowed inside the campus during the college working days.



- **Air Pollution Management**  
Environment pollution control awareness programmes are conducted on various issues to create awareness among students and staffs. The college itself is a house to a number of oxygen rich green plants. Tobacco and tobacco products are strictly prohibited in the college premises and consuming tobacco and tobacco

products is a punishable offence. The college has also restricted the use of automobiles within the campus to reduce air pollution.

- **Water, soil, and land pollution Management**

The college has adopted various measures to ensure the protection of land water and soil from pollution. The college strictly adhere to the practice of using only bio fertilizers and completely prohibits the use of chemical fertilizers which can lead to water, land and soil pollution.

## **19. MENTAL AND PHYSICAL HEALTH**

The college has initiated various measures for both mental and physical well-being. For ensuring menstrual hygiene Pad vending machines are installed in girl's common room. Infirmary is set up in the college for providing first aid and other helps.



Yoga is a perfect way to attain both mental and physical well-being and for the same reason the college promotes practising yoga on and off the campus. The Centre for Environmental Studies takes initiative by organising mass yoga drills on International Yoga Day each year.







## **20. MOU FOR SOLID AND E-WASTE RECYCLING**

Mar Gregorios College of Law has adopted measures for solid waste and e-waste recycling with the assistance of Clean Kerala Company Limited. Clean Kerala Company Limited is an institution formed under the Local Self- Government Department of Government of Kerala. Clean Kerala Company Limited has entered to an MoU with our college for the collection of recyclable plastics and E-wastes
